Active bidding begins at 10 a.m. and continues until 7 p.m. on Aug. 12, 2022.
Help is Available: For interested bidders without internet access, a phone bidding system is available by calling (800) 259-7470. In-person computer access is available at the Oakland County Treasurer's Office during business hours on Monday-Friday from 8:30 a.m. to 4:30 p.m. Residency proof or an appointment is not required.

Residential and commercial properties along with vacant parcels are available for purchase.

To participate in the virtual tax foreclosure property auction, bidders must register for a free user account and must submit a credit card pre-authorization before bidding.
